Fee notes:

- 1 Hourly rates as shown. All other fees are flat rates per item. Hourly rates will be billed in ¼ hour increments. All travel time for inspections in Ontario are covered by a flat travel charge or other flat rates as applicable. Out of province travel time will be billed at actual time, at the applicable rate, and expenses. Overtime rates will apply for services delivered outside normal business hours at the request of the customer. Expedited Engineering Service fees will apply when the TSSA "Application for the Provision of Expedited Engineering Services" is submitted. Expedited Engineering Service is a premium rush service provided at the request of the customer, and is normally completed within a 5 working day turnaround. Expedited service premiums are non-refundable if delays are a result of missing information from the customer.
- 2 For inspections that an inspector has been deployed to service, and which is subsequently cancelled by the requestor as not ready or not required, a flat travel charge will be applied.
- 3 Expedited Inspection Service is available and will be charged whenever customer requested work takes the inspector away from previously scheduled work. Expedited service is billed at double the standard fee.
- 4 For > 200 hours and ≤ 1,000 hours per annum, a 4% rebate is applied to the fee. The rebate does not apply to the first 200 hours. For any hours above 1,000 hours per annum, a 6% rebate is applied. Rebates are issued 60 days after TSSA's April 30 year-end, subject to no outstanding payments.
- 5 Periodic inspection fee is charged on a per boiler or pressure vessel basis.
- 6 Other Inspections include: Piping Inspections, Repair or Alteration Inspections, First Inspections, Install Inspections and Special Inspections.
- 7 One flat travel charge will be added for each inspection visit, with the exclusion of the following inspection types: (a) audits, (b) QAS visits, (c) agency surveys and (d) welder/brazer tests.
- 8 Licensing, registration, certification and examination fees are non-refundable. Examination fees are payable for all examinations and re-writes taken by the candidate, regardless of whether the outcome is a pass or a failure. An exam re-write counts as a separate examination and will be billed accordingly.
- 9 The fees in this schedule are required deposits for the audit. Additional fees may be applicable as identified in the relevant Application.
- 10 The COI fee applies to First, Installation and Alteration inspections.
- 11 The Periodic COI fees apply only to Periodic inspections as follows: \$40 for annual inspections, \$80 for biennial inspections, or \$115 for triennial inspections
