### Liquid Fuels Handling Code Adoption Document

The Gasoline Handling Code published by the then Fuels Safety Branch of the Ministry of Consumer and Commercial Relations and dated, January 1, 1993 and the standards and specification set out in it are hereby adopted as part of the regulation and shall be complied with by all persons engaged in the handling of liquid fuels or in the sale, installation, maintenance, repair or removal of liquid fuels handling equipment from June 27th, 2001 until September 30th, 2001 whereupon it is no longer effective and the Liquid Fuels Handling Code issued by the Technical Standards and Safety Authority, dated August 1st, 2001, as amended from time to time, is hereby adopted effective October 1st, 2001 as part of the regulation and the standards and specifications set out in it shall be complied with by all persons engaged in the handling of liquid fuels or in the sale, installation, maintenance, repair or removal of liquid fuels handling equipment.
