

## CONSENT TO GRANT THIRD PARTY ACCESS

- a. submit applications on my behalf for TSSA authorizations or for services provided by TSSA, including supporting documents and information;
  - b. communicate with TSSA, and make representations, warranties and binding decisions on my behalf to TSSA;
  - c. access my account on TSSA’s self-service portal and manage my account, including creating, updating and maintaining my account;
  - d. make payments to and receive refunds from TSSA on my behalf; and
  - e. access all my records and information held by TSSA.
2. I understand that TSSA will not contact me for approval or confirmation with respect to any action taken or made by the Third Party Agent on my behalf.
3. I understand that the Third Party Agent will select its own employees and agents who will act on behalf of the Third Party Agent, and that every such employee and agent will have full authority to deal and transact with TSSA on my behalf as described above and that TSSA will not manage, vet or otherwise control who such access is granted to, nor will TSSA notify me when the Third Party Agent replaces, adds or removes its authorized employees and agents.
4. I may revoke this consent at any time by providing TSSA with clear written instructions to that effect, which TSSA will make reasonable effort to effect in a reasonable timeframe. I understand that it is my responsibility to manage and track my Third Party Agent and to revoke this consent if and when needed.

5. I AGREE TO INDEMNIFY AND HOLD HARMLESS TSSA FOR ANY LOSS, DAMAGE OR HARM THAT TSSA OR THE SERVICE ACCOUNT OWNER OR ANY OF THEIR RESPECTIVE DIRECTORS, OFFICERS, EMPLOYEES, AGENTS, AFFILIATES, INSURERS OR ANY THIRD PARTY MAY INCUR OR SUFFER IN ANY WAY RELATED TO THE GRANTING OF THIS CONSENT.
