- J. Callow renewed his membership. K. Kennedy noted two candidates were proposed for the contractor and distributor vacancies.

It was agreed to leave the Transporter/Carrier: category vacant for now as it doesn't directly affect the TSSA regulatory remit. The Chair requested clarity on the status of Superior Propane's status.

**Action:** K. Kennedy to follow up with D. Karn on the status of Superior Propane's membership of the advisory council.

- **4.** Chair Report

The Chair did not have an update.

He noted that R. Loenhart is the new chair starting the next meeting. D. Karn will co-host.

- 5. Propane Compliance Standard
- S. Cooke provided the update, providing a background on the purpose of TSSA compliance standards, how they are developed and the next steps, noting an April 14 in-force date.

For the Record of Training (ROT) non-compliance, S. Cooke was asked if regulated customers will be required to produce their ROT on demand. In some instances, it is not practical to do so. S. Cooke said the regulation says the ROT documentation should be physically on the individual. Transport Canada, by contrast, requires that certain items, like paper or wallets, are not on the person while on site at facilities. There was a discussion on what "readily accessible"

means in practice. S. Cooke explained that TSSA will be reasonable in requesting the ROTs.

- 6. Issue Prioritization Update
- G. Highfield provided an update on the priorities from previous meetings.

J. Mitchell asked what TSSA's objective is for truck licensing for TSSA, especially since Transport Canada not only licenses trucks but does more oversight than TSSA. TSSA only does an initial inspection. G. Highfield indicated that the goal is licensing and to build up an information database on regulated customers' fleet vehicles. D. Karn noted that the issue is the fee, rather than licensing and databases per se. R. Loenhart asked if he can find out what it is that TSSA looks for in its initial inspection so that he can possibly add the requirements to the Transport Canada standard for bulk trucks. It was noted that the proposal for distributor licences could include reporting of trucks under the distributor licence.

For the GUT (gas distributor technician) certification, there was a discussion about the nature and scope of the certificate. TSSA is reviewing regulatory restrictions internally. K. Johnson suggested going back to Brent Caren to make sure PAC and TSSA have accurately characterized the issue as he sees it.

On quality assurance, CPA will put out a communication in the CPA newsletter indicating that quality assurance programs are an option and what the next steps are.

R. Loenhart raised off-agenda issues. One was TSSA inspections where inspectors are demanding National Board requirements for bulk plants. G. Highfield had suggested as a solution for the bulk plants industry, might want to consider the best practices for bulk tank inspections. Industry can create a working group then come back to TSSA with proposals so it can be included in the CAD amendment. S. Ko is aware that this information will be forthcoming. D. Karn noted that this issue is identified in the Compliance Standard. G. Highfield will raise it with O. Kennedy.

For incident reporting, R. Loenhart asked about anonymous examples of incidents from incident reporting for training purposes. Real life scenarios are invaluable for training.
