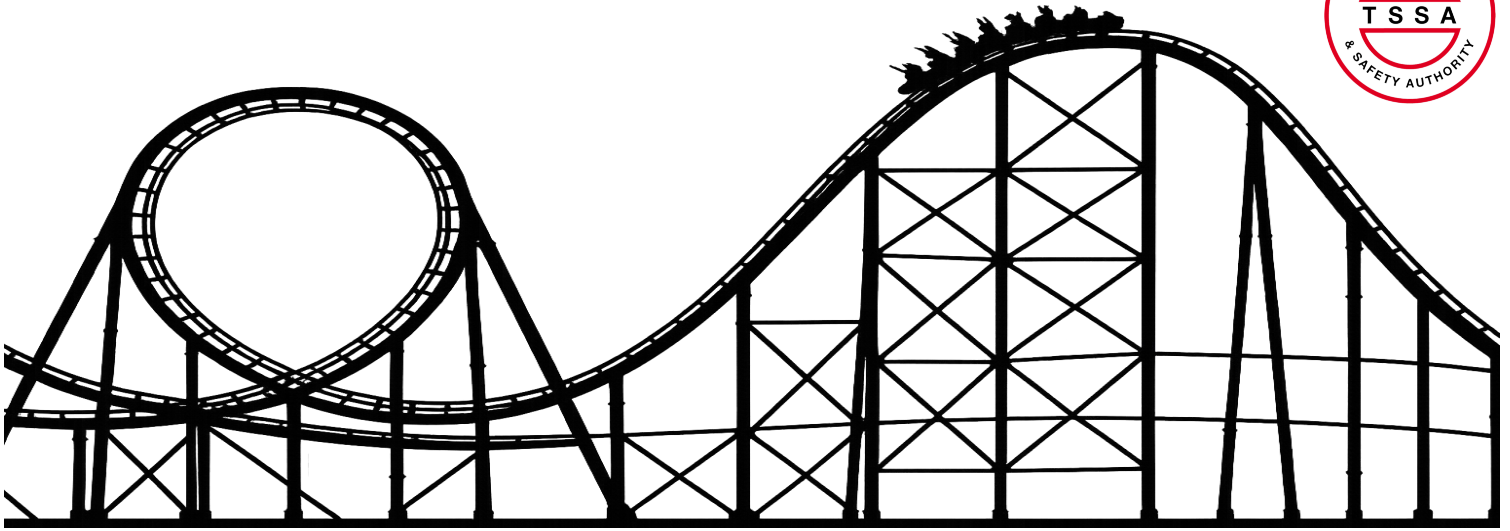


TSSA Amusement Ride Safety Training Forum 2026
